CERTIFIED MENTORCOACH[®] (CMC) CERTIFICATION REQUIREMENTS AND APPLICATION PROCESS

Please find below detailed information of the requirements to sit for the MentorCoach[®] CMC Final Written & Oral exams.

Submission of a CMC Final Written Exam Application is available for:

- Graduates of the four required MentorCoach[®] Training Program courses:
 - Foundations (25 student learning hours)
 - Intensive Individual Coaching Skills master class (24 student learning hours)
 - Safe Passage: The New Ethics and Risk Management master class (10 student learning hours)
 - Individual Coaching Supervision master class (24 student learning hours)

Total: 83 hours

- Graduates of at least a total of forty-two (42) hours of MentorCoach[®] training program elective courses (see chart below).
- MentorCoach[®] students who have received the required mentor coach coaching, coaching supervision, and coaching experience listed below.

There are two application deadlines and two testing periods each calendar year. Applications for any **MentorCoach[®] Certification offered** can be submitted between January 1 and March 31 (postmarked deadline 3/31) or between July 1 and September 30 (postmarked deadline 9/30) each year.

Applicants should review their abilities to meet the requirements detailed below to determine whether they should submit a CMC Final Written Exam Application, or continue working to obtain all of the required coach specific training and experience.

Mentor Coaching	Ten (10) hours_of Mentor Coaching using an approved MentorCoach® Provider is required for ICF/MentorCoach® certification. Mentor Coaching should take place concurrently with--or after the completion of-- the Supervision Master Class.

Coaching Experience	<p>Client Coaching documenting:</p> <ul style="list-style-type: none"> • A minimum of 100 client coaching hours • A minimum of 75 paid client coaching hours • A minimum of 8 clients <p>All CMC Final Written Exam applicants will be required to complete 100 hours of client-coaching experience <u>following the start of your training with MentorCoach®</u>. At least 25 of these hours must occur within the 18 months prior to submitting your CMC Final Written Exam application.</p>
Examination	<p>Successful completion of the Certified MentorCoach® (CMC) Final Written & Oral Exams:</p> <ol style="list-style-type: none"> 1. The CMC Final Written Exam includes, multiple choice sections covering the four (4) required courses; Foundations, Intensive Individual Coaching Skills, Safe Passage: the New Ethics & Risk Management and, Individual Coaching Supervision, the applicants selected elective courses, and three (3) essay questions. 2. Oral exam – Live coaching exam by Zoom teleconference. <p>A passing grade of 70% is required to pass the CMC Final Written and Oral Exams. Feedback is <u>only</u> provided on the Oral exam.</p>
Fees	<p>\$875 for the technical review of the application and administration of the Final Written and Oral Exams.</p> <p>\$150 Retake Exam Fees for Written or Oral Exams.</p>
